



The Essential Package of Health Services and Health Benefit Plans in Ghana



About the health benefit plan crosswalk analysis

An Essential Package of Health Services (EPHS) is a broad policy statement that identifies the services that a government has prioritized. The government seeks to ensure that these essential services reach the population equitably. A health benefit plan (HBP) specifies an explicit set of services and the cost-sharing requirements for beneficiaries to access those services.

In 2015, the USAID-funded Health Finance and Governance (HFG) project completed a landscape analysis of the EPHS in the 24 USAID priority countries for Ending Preventable Child and Maternal Deaths (EPCMD). The analysis found that the government in most of the countries intends for the public and/or private not-for-profit facilities in the country to deliver the services in the EPHS. It also showed that several governments were implementing major HBPs (such as social health insurance schemes) as a primary strategy for moving toward universal health coverage. Yet it remained unclear how the EPHSs and HBPs are formulated, how they are modified, and the extent to which they overlap.

HFG conducted a second landscape analysis in 2016 to identify existing HBPs in the countries, and the services they cover. It then did a crosswalk analysis – a mapping of items on one list to equivalent items on another list – of the services specified in the country's EPHS and those identified in an HBP. This companion analysis to the EPHS country snapshot documented the degree of alignment between the EPHS and HBP.

This brief presents HFG's findings and observations for policymakers and program managers seeking to promote alignment of services in the EPHS with services covered in the HBP and move toward universal health coverage.

Ghana's Ntional Health Insurance Scheme

National Health Insurance Scheme

The National Health Insurance Scheme (NHIS) in Ghana was launched in 2003. It stemmed from a promise by the National Patriotic Party to develop a more equitable health care system with an ultimate goal of universal health coverage. Though this scheme is mandatory for all citizens, participation is not enforced and 34 percent of the population was covered as of 2014. All Ghanaians, with the exception of military service members and police officers, are eligible for enrollment.

The NHIS encompasses a national risk pool, and provides subsidized premiums for key populations. Seventy-five percent of its funding comes from a value-added tax (VAT) of 2.5 percent on goods and services. Premiums from informal sector households contribute an additional 5 percent of its revenue. The remaining funding comes from a 2.5 percent social security tax from formal sector workers and additional ad hoc donor funds.

The NHIS is managed by the National Health Insurance Authority (NHIA), which oversees revenue collection, pooling, and purchasing. Citizens enroll into the scheme by applying in person at their district NHIS office. The scheme subsidizes premiums for children under 18, adults over 70, the poor, and pregnant women. All other members must pay an annual premium ranging between US\$8 and US\$12 per year. Enrollees can access care at accredited public and private health institutions without a co-payment.

Methodology

HFG identified all major HBPs operating in the country through a desk review of public domain sources found through web-based searches, including: government strategy documents, studies and reports, peer-reviewed journal articles, news articles, and gray literature. A list of sources reviewed is at the end of this document. We collected information across all 24 countries using a common template. We analyzed the HBPs operating in the country which:


- are fully or partially publicly financed
- employ a risk-pooling mechanism to provide financial protection to beneficiaries when they access covered services.

HFG determined whether the HBP had an explicit, published list of covered services. We compared services included in the government's EPHS to those in the HBP using Microsoft Excel. To indicate how each service included in the EPHS relates to those in the HBP, we established a color-coded system as follows:

Main observations from the crosswalk



- Ghana does not have a specified EPHS, but has defined multiple packages of health services in various government programs. For this exercise, HFG compared the HBP for the NHIS to the Community-based Health Planning and Service program (CHPS), a national initiative to provide mobile community-based care in rural areas, in place of an EPHS.
- The HBP includes Caesarean sections and OB/GYN emergencies, but does not specify whether normal delivery is included.

- The HBP does not explicitly mention contraceptives, though various family planning methods are listed in the CHPS.
- CHPS lists comprehensive maternal health services, while the HBP only refers to emergencies.
- ▶ The HBP does not include newborn care.

The detailed crosswalk is shown below. The tables present the health services essentially as written in the official health policy documents, although HFG has edited them where necessary to maintain a consistent style across this series of country briefs
